- Four (4) copies of a diagram showing the dimensions of the property, and the length and location of the proposed boat dock (including the location of any conservation easements, tracts, or conservation areas).

NOTE: As stated in Section 15-342 of the County Code, the diagram **must** also show the following:

- The current and Normal High Water Elevations (NHWE).
- Lake name.
- A north arrow .
- The exact distance between the shoreline and a permanent object or construction.
- The exact distance of setbacks from adjacent property lines.
- The floor elevation of the proposed dock and the floor and roof elevation of any boathouse or other structure connected to the dock.
- The depth of the water at the end of the proposed dock.
- The location of any conservation easements, tracts, or conservation areas.
- A property survey.
- A notarized letter from each adjacent property owner stating "No Objections", **OR**
